9. Highway/Amenity Items:

- a) The dangerous manhole cover situated on the verge as you approach Ashford Carbonell Bridge travelling towards Ludlow had been repaired by Shropshire Council.
- b) The Chairman raised concerns by residents at the speed of traffic using the Caynham Road as they approach the narrow Ashford Carbonell Bridge travelling towards Ludlow and was more dangerous when there is a build up of traffic during School Hours. The Parish Council agreed to ask Shropshire Council to provide more warning signs about the narrowness of the bridge.
- c) The Parish Council agreed to buy two grit salt bins and appropriate grit to be sited near the junction of the Village Green and in Donkey Lane near to the Church at a cost of £455.96.
- d) The Parish Council considered the provision of a new parish notice board for the village and suggested that this would need to be sited by the Village Hall.
