### **The Minutes of the Meeting of the Parish Council Meeting held at Ashford Carbonell Village Hall on Wednesday 15<sup>th</sup> July 2015 at 7.00pm**

#### **1. Present:**

#### **3. Items from Shropshire Councillor Mrs V Parry**

Mrs V Parry reported that she had been appointed as a representative on the West Mercia Police Crime Panel and gave an update on Shropshire Council matters which included planning, youth service and the IPE service.

#### **5. To approve the Minutes of the Previous Meeting:**

#### **7. Chairman's Communications**

The Chairman reported that the Ashford Carbonell War Memorial had been added to the List of Buildings of Special Architectural or Historic Interest. The memorial is now listed at Grade II.

#### **8. Planning Items:**

The Parish Council had no objections to the following planning applications:

- a) Planning application 15/02801/TCA – to reduce in height by 8ft 1 beech tree – Springfield House
- b) Planning application 15/02285/Ful – To convert existing attic workshop into 2 bedrooms and re-configuration of internal layout to include dormer windows to rear elevation and Velux roof lights – Old Lane House
- c) Planning application 15/02465/Ful – Erection of a side and rear extension and garage conversion to provide additional living accommodation
- d) Planning application 15/02671/Ful -15/02722/TCA – Works to trees (schedule of works attached) including the felling of a group of trees - Ashford Mill

The Clerk will make enquiries about the provision of a new safety warning notice to be sited near the weir at Ashford and that consideration will also be-given to the provision of a lifebuoy.
