5. To approve the Minutes of the Previous Meeting:

The minutes of the meetings dated the 13th July 2016 were approved by the council and signed as a correct record by the Chairman.

6. Matters Arising from the Minutes:

The Clerk reported that he had been informed by Shropshire Council that the Horse Chestnut Tree situated on the grass verge by the Village Green behind the Dumblehole road sign has got a disease called Bleeding Canker which is causing the bark cracking and the foliage is being damaged by an insect called Horse Chestnut Leaf Miner and is likely to be felled. The Clerk to enquire when the felling work is to be undertaken.

7. Chairman's Communications

The Chairman reported that the next meeting of the Ludlow and Clee Area Local Joint Committee is to be held at Ludlow on Thursday 29th September 2016 commencing 7.00pm which will consider the Health Service in Shropshire.

9. Highway/Amenity Items:

- a) Mr D Brundrett will contact the school to enquire when the overgrown hedge running along the highway into the village is scheduled to be cutback.
- b) The Clerk to enquire with Shropshire Council Highways when Ashford Bridge is due for inspection.
- c) The Parish Council considered the issue of speeding through the village and the request for a 30mph speeding limit through the village.

The Clerk referred to the Automatic Traffic Counter Data obtained from a survey held in October 2007 and showed average speeds of approximately 32mph which would unlikely vary if undertaken again.

The Clerk held a site meeting with Mr I Rutherford Shropshire Council Highways and it was suggested that the Parish Council may wish to consider the provision of a 30mph advisory near to the entrance of the village the cost of the sign would have to be meet by the Parish Council.

It was agreed by the Parish Council to request the provision of the 30mph advisory sign the cost of which would be borne by the Council and to keep the matter under review.
