8. Highway/Amenity Items:

- a) The Clerk to pursue the replacement Ashford Carbonell sign at the A49 Junction.
- b) The Clerk to pursue the cutting of the trees that overhang the Caynham Road which have dead branches and lean at a significant angle and are a hazard and potentially dangerous to road users. Shropshire Council had visited the site and had requested the owner of the trees to undertake the required work.
- c) The Clerk reported that a response had been received from Shropshire Council concerning the Vehicle Activated Sign by Caynham School which is to be repositioned to its original location further along the Caynham Road giving more advanced warning to road users travelling from Caynham towards Ashford and the before the 30mph speed restriction. The sign will be sourced with an improved solar panel system with an additional battery backup supply as opposed to an electrical supply which due to cost and ownership difficulties cannot be achieved. The Parish Council had no objection to the proposed solution which should be implemented before the September Term commences.
- d) The Chairman read out correspondence that she had received concerning the narrowness of the roadway over the bridge travelling to and from Ashford Carbonell on the Caynham Road and although the Parish Council appreciated the points raised this had been the situation for many years with local road users aware of the dangers and also there was an alternative route available to road users.
